7.2 Explanation of the difference in loss (decrease) of over 10% in after-tax profit compared to the same period:

- Explanation of loss in the 4th Quarter of 2024

After-tax profit in Q4 2024 is: (656,225,320) VND, the reason for the loss in Q4 2024 is due to low revenue during the period and high cost of goods sold, but the enterprise still incurred management costs to maintain operations and at the same time, during the period, another expense arose with the amount: 387,115,789 VND, this is the interest expense for late payment of tax according to the notice of the tax authority.

- Explain the reason for the difference in loss increase of over 10%

Profit after tax in Q4 2024 is: (656,225,320) VND and Profit after tax in Q4 2023 is: (298,046,231) VND, the reason for the difference in loss increase of over 10% of Q4 2024 compared to Q4 2023 is due to low revenue in Q4 2024, high cost of goods sold and at the same time, other expenses arose in the period with the amount: 387,115,789 VND, this is the cost of late tax payment interest according to the tax authority's notice, leading to an increase in loss of Q4 2024 compared to Q3 2023
